LOUIS REGIONAL AIRPORT AUTHORITY, County of Madison and State of Illinois, as the same is assessed and equalized for State and County purposes, for 2025, payable in 2026 for the purpose of paying the cost of operation and maintenance of the public airport facilities and other corporate expenses of said Authority, a tax sufficient to produce the sum of \$762,000 which sum together with \$2,183,500 to be received and derived and which will be available from other miscellaneous sources, being in total the sum of \$2,945,500 which is the total amount of appropriations legally made for said taxable year, which sum is to be used for and has been appropriated for the purpose in the amount specified in detail as follows:
